4. That, the following are the members of the School Management Committee of Hariharananda Balashram, Arua, Kendrapara.

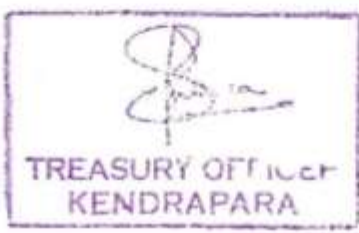
