Pursuant to the decision of the High Power Committee in its meeting dated 27.6.2013 and Govt. Letter No. 17937/SME dtd. 31.7.13 and as per the guidelines issued by the Govt. in the Department of School & Mass Education, Odisha, Bhubaneswar vide Resolution No. 30720/SME dtd. 23.9.96 read with G.O No.-29519/SME dtd. 26.9.1998, No Objection Certificate (NOC) is hereby granted in favour of Harihara Nanda Balashram, At- Arua, P.O. Kadaliban, Dist. Kendrapara to open an un-aided High School which is to be affiliated to CBSE subject to the following terms and conditions.

- The No Objection Certificate now issued shall be subject to the terms and conditions as prescribed in G.O No. -30720/SME dtd. 23.9.96 and No. 29519/SME dtd. 26.9.1998 read with G.O No. – 10011/SME dtd. 11.6.2004
- 2. The school shall be open for inspection by the Inspection Committee.
- 3. No Financial assistance and Grant-in-Aid (both recurring & non-recurring) will be claimed by the institution from the Government at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee or for meeting any other expenses for managing the school.
- 4. The High Power Committee shall be competent to review the NOC granted to the institution concerned and shall be competent to withdraw the same if any of the terms and conditions contained in G.O No. 30720/SME dtd. 23.9.96 and No.-29519/SME dtd. 26.9.98 read with G.O No.-10011/SME dtd. 11.6.2004, is /are violated at any time.
- The Managing Committee shall be constituted in accordance with the Sec-7 of the Orissa Education Act-1969.
- 6. The Managing Committee of the school will not shift the present location of the school without prior approval of Director, Secondary Education, Odisha.
- 7. The Managing Committee shall ensure the continuity of all eligibility criteria for Grant of N.O.C. If any deterioration from present status of the school is detected at any point of time then the N.O.C shall be withdrawn.
- 8. All schools be registered in web-portal in OPEPA website.
- If any point of time it is found that information submitted by the school is not in conformity with the field position, appropriate legal action against the school authority will be initiated besides withdrawal of N.O.C.

Grant of N.O.C is also subject to the fulfillment of the following requirements:

- i. Own building of the school be completed within a period of one year from the date of issue of NOC as per Govt. order No.5345/SME dtd. 26.3.10.
- The members of the staff of the school be paid salaries at par with the salaries of the State ii. Government with effect from the date of issue of N.O.C.
- iii. The medium of instruction in the school shall be English or any other Indian language but Odia shall be taught as a subject to all pupils in the institution compulsory except the domiciles of other states and pupils of public servants on transfer from other states.
- iv. The copy of the record of rights in favour of the land where the school is situated is to be furnished to this Directorate by the concerned school authority within a week of receipt of the approval.

The organization/individual which has applied for N.O.C will submit an affidavit within a period of one month to the effect that it has fulfilled the above requirements, failing which the N.O.C will be withdrawn.
